Subscriptions Some parts of the Service are

billed on a subscription basis ("Subscription(s)"). You will be billed in advance on a recurring and periodic basis ("Billing Cycle"). Billing cycles are set either on a monthly or annual basis, depending on the type of subscription plan you select when purchasing a Subscription. At the end of each Billing Cycle, your Subscription will automatically renew under the exact same conditions unless you cancel it or Skin Wellness Center cancels it. Termination

The following fee structure will be made effective if Service is terminated:

- \$35/month if cancelled within six months of the first twelve months of service
- \$25/month if cancelled in months six to twelve of the first twelve months of service
- Termination fees will be billed to subscriber via mailed invoice and must be paid in full before any further services can be scheduled with any provider at Skin Wellness Center.
- Extenuating circumstances will be considered on a case by case basis.

All provisions of the Terms which by their nature should survive termination shall survive termination, including, without limitation, ownership provisions, warranty

disclaimers, indemnity and limitations of liability.
